a) **WOMEN SHG Formation** : Saving and Credit have formed 250 SHG so far and savings habits promoted among the SHG members, trainings and capacity building sessions were organized for 250 women leaders from SHG'S on micro credit, health, nutrition, environment and women and child rights.
